

## **HMD Fusion X1 & 3 Months Free Subscription Terms and Conditions**

**Promotion Period from 6<sup>th</sup> January 2026 to March 31<sup>st</sup> 2026.**

The following Terms and Conditions apply to the above-named Promotion and are subject to change without notice. The Promotion is held by HMD Global.

### **About the Promotion**

In this Promotion, Eligible customers who have (i) purchased an HMD Fusion X1 device (“Eligible Device”) in the Republic of Ireland from the Participating Partners during the Promotion Period, and (ii) activated the Eligible Device and the Xplora parental control subscription on the guardian device before 10<sup>th</sup> April 2026, 23:59 GMT time, will receive the Xplora parental control subscription service for a three (3) month period from the date of activation. After the free subscription period of three months, the Xplora parental control subscription will automatically continue as a paid subscription for €5.99 per month in accordance with [Xplora Terms and Conditions](#).

One free Xplora parental control subscription for three months is received per each purchased Eligible Device.

The Promotion Period is from 6th January 2026 to March 31st 2026, and subject to the stock availability.

### **HMD Global and their rights as the Organizer of the Promotion**

1. HMD Global reserves the right at its absolute discretion to disqualify customers' claims which it considers do not comply with these Terms and Conditions.
2. HMD Global shall have the right, where necessary, to undertake all reasonable action to protect itself against fraudulent or invalid claims including, but not limited to, requiring further verification of proof of purchase, as well as the identity, age and other relevant details of a participating customer.
3. HMD Global shall not be liable for any interruption to the Promotion due to circumstances force majeure or other factors beyond the control of HMD Global.
4. HMD Global reserves the right, acting reasonably and in accordance with all relevant legislation and codes of practice, to alter the Terms and Conditions of the Promotion without notice.

  - a. Any failure to activate the Eligible Device and the Xplora parental control subscription on the guardian device in time to qualify for the Promotion due to any failures and other conditions beyond the reasonable control of HMD Global.
  - b. Customer claims that are late, lost, misrouted, or damaged.

- c. Any malfunctions or failures pertaining to communications and the use of computers.
- d. Any disruptions, losses or damages caused by events beyond the control of the HMD Global.
- e. Any printing or typographical errors in any materials associated with the Promotion.

### **”Eligible customer(s)”**

To qualify for this Promotion, customers must meet the following eligibility criteria:

1. The customer must be a resident of Ireland, where the purchase and redemption happen in the same country.
2. The customer must be over 18 years old as of the date of entry.
3. The customer must purchase HMD Fusion X1 during the Promotion Period between 6th January 2026 date to March 31<sup>st</sup> 2026 inclusively.
4. The customer must purchase HMD Fusion X1 from the Participating Partners.
5. The customer must be in possession of the purchased HMD Fusion X1 and must not have returned the device for a refund or exchange. If customers return the purchased HMD Fusion X1, HMD Global reserves the right to cancel the remaining part of the three months free Xplora parental control subscription.

Participating Partners include Harvey Norman Ireland and Vodafone Ireland.

### **Responsibilities of the participating customer**

1. Participants will be solely responsible for any and all applicable taxes and any other costs or expenses that arise from participation of the Promotion which are not stated in the Terms and Conditions as being included.

By participating in this Promotion, the customer agrees, to the extent permitted by applicable laws, to hold the promoter harmless from any and all liability whatsoever for any injuries, losses or damages of any kind arising from participation in or in connection with the Promotion. ## **Restrictions**

The Promotion is subject, but not limited to, the following restrictions:

1. Eligible customers will be able to claim the Xplora parental control subscription for free for three (3) months per one HMD Fusion X1 purchase.
2. The Promotion is valid only while stocks last.
3. Customers who purchase their HMD device outside of the Promotion Period are not eligible to enter this Promotion.
4. Employees or agents of HMD Global that are involved in the operation of this Promotion or any other persons working on the Promotion in a professional capacity are not eligible to participate in this Promotion.
5. Network providers, retailers, distributors, resellers and any person who purchases an HMD device for purposes other than to be the user of the product – for example, resale purposes – may not participate in this Promotion.
6. This Promotion is non-transferable and there is no cash alternative.

## **How Eligible customers can claim their three months free subscription service.**

Eligible customers will be able to claim the free three-month Xplora parental control subscription by activating the Eligible Device and the Xplora parental control subscription on the guardian device before 10<sup>th</sup> April 2026, 23:59 GMT time.

## **Limitation of Liability**

By entering, customers agree to release and hold harmless Organizer and its subsidiaries, affiliates, advertising and Promotion agencies, partners, representatives, agents, successors, assigns, employees, officers and directors from any liability, illness, injury, death, loss, litigation, claim or damage that may occur, directly or indirectly, whether caused by negligence or not, from (i) such entrant's participation in the Promotion and/or his/her acceptance, possession, use, or misuse of any prize or any portion thereof, (ii)
