

Smartwatch discount offer – Black Friday 2024

These terms and conditions apply to the Vodafone Bill Pay Black Friday 2024 promotional offer pursuant to which Eligible Customers can receive a €60 discount off smartwatches when they purchase a smartwatch during the Offer Period (the “Offer”). The promoter of the Offer is Vodafone Ireland Limited. These Offer terms will apply in addition to the [General Terms and Conditions](#) under which you enjoy access to Vodafone's Mobile Telecommunications Services, the [Smartwatch Bundle](#) terms and any additional applicable service specific terms that you have signed up to.
