

Bill pay Black Friday upgrade offer

These terms and conditions apply to the Vodafone Bill Pay Black Friday 2024 promotional offer pursuant to which Eligible Customers can receive a €50 discount off selected handsets when they upgrade to a 24-month RED Lite or RED Unlimited bill pay plan during the Offer Period (the “Offer”). The promoter of the Offer is Vodafone Ireland Limited.  - b. Samsung Galaxy S24
