

Google Pixel 9 Pre-order General Terms and Conditions

These Pre-Order Terms and Conditions (the "Pre-Order Terms") govern the placing of pre-orders with Vodafone Ireland Limited ("we", "us", or "Vodafone") for the Google Pixel 9, Pixel 9 Pro and Pixel 9 Pro XL mobile handset devices ("Eligible Handsets" and each an "Eligible Handset"). Please read these Pre-Order Terms carefully before submitting your pre-order. By submitting your pre-order, you agree to be legally bound by these terms:

1. The pre-order period for the Eligible Handsets is from 13th August 00:00 (GMT) to 21st August 23:59 (GMT) (the "Pre-Order Period"). The Eligible Handsets will be available for general sale on 22nd August 2024.
2. The pre-order is available to Eligible Customers only.
