#### 1. GENERAL

Service Summary: Vodafone Business Online (the "Product") is a set of website and e-Commerce shop creation services, provided by us as Do-It-Yourself (DIY) or Do-It-For-Me (DIFM) services and are based on Vodafone's Online Presence Builder platform (VOPB). The specification for the Product ("Product Specification") is at Appendix 2 to these Product Terms. Please see Table 1 of the Product Specification for all available editions).

#### 2. ACCEPTANCE

You agree to be bound by all of the terms and conditions set out in these Product Terms;

#### 3. INTELLECTUAL PROPERTY

- 1. Through our Products, you will be provided with objects including their API's as well as images, photographs, templates, animations, video, audio, music, text and "applets", and "online" or electronic documentation (together called the "Digital Content").
- 2. You may use, modify and publish the Digital Content in accordance with our contract with you.
- 3. Any supplemental software code and supporting materials provided to you as part of support services for the Digital Content shall be considered part of the Digital Content and are subject to our contract with you.
- 4. The copyright and all other rights to the Digital Content shall remain with our licensors.
- 5. Permitted Use Of Digital Content:
- 5.1. You may incorporate the Digital Content into your own original work and publish your work in a web site provided that:
- 5.1.1. The Digital Content is incorporated for viewing purposes only and no permission is given to download or save the Digital Content for any reason; and
- 5.1.2. You continue to pay for our Products.
- 6. Unauthorized Uses Of Digital Content:
- 6.1. You may not:
- 6.1.1. Post web pages containing the Digital Content on servers other than those owned or operated by us or our suppliers;
- 6.1.2. Use the Digital Content for any purpose, if you no longer pay for our Products;
- 6.1.3. Use the Digital Content to create printed or "hard copy" documents:

- 6.1.4. Use the Digital Content in electronic format, on-line or in multimedia applications unless the Digital Content is incorporated for viewing purposes only and no permission is given to download or save the Digital Content for any reason;
- 6.1.5. Use the Digital Content in web page design whereby the Digital Content is in a format designed or intended for storage or re-use by others;
- 6.1.6. Use or permit the use of the Digital Content or any part thereof as a trademark or service mark, or claim any proprietary rights of any sort in the Digital Content or any part thereof;
- 6.1.7. Use the Digital Content with images of identifiable individuals, products or entities in a manner that suggests their association with or endorsement of any product or service;
- 6.1.8. Create scandalous, obscene, defamatory or immoral works using the Digital Content, nor use the Digital Content for any other purpose which is prohibited by law;
- 6.1.9. Translate, reverse engineer, decompile, or disassemble the Digital Content;
- 6.1.10. Rent, lease, assign, transfer or redistribute the Digital Content or a copy thereof, to another person or legal entity; or
- $6.1.11. \ Use the Digital Content or make copies of it except as permitted in our contract with you.$

#### 4. TERMINATION EFFECTS

You agree, upon termination of our contract with you, to cease using and destroy all copies of the Digital Content.

#### 5. GENERAL

In the event that we notify you that certain components of the Digital Content may no longer be used (for whatever reason), then such components cannot be used as part of a web site design or template layout, nor can they be used in any other larger work. If you receive such notification, you agree to cease using and destroy all copies of those components of the Digital Content identified by us in your possession or control.

#### 6. DISCLAIMER

Although we will use commercially reasonable measures to maintain the security of the Products, we assume no responsibility for the effectiveness of these security measures.

#### 7. PROHIBITED CONDUCT

- 7.1 You agree to refrain from the following examples of prohibited conduct:-
- 7.1.1 Spamming
- (a) Sending unsolicited bulk and/or commercial messages over the Internet (known as "spamming")
- (b) Maintaining an open SMTP relay
- 7.1.2 Facilitating a Violation of this paragraph 7  $\,$
- 7.1.3 Advertising, transmitting, or otherwise making available any software, program, product, or service that is designed to violate this Policy, which includes the facilitation of the means to spam, initiation of pinging, flooding, mailbombing, denial of service attacks, and piracy of software

#### 7.1.4 Infringing intellectual property rights

#### 7.1.5 Engaging in any activity that:

(a) infringes or misappropriates the intellectual property rights of others, including copyrights, trademarks, service marks, trade secrets, software piracy, and patents held by individuals, corporations, or other entities

(b) violates privacy, publicity, or other personal rights of others

#### 7.1.6 Obscene Speech or Materials

(i) Using our Products to advertise, transmit, store, post, display, or otherwise make available child pornography or other forms of illegal pornography or obscene speech or material. We shall notify law enforcement agencies when we become aware of the presence of child pornography on or being transmitted through our Products

#### 7.1.7 Promoting Violence or Injury

- (a) Advocating, promoting or providing assistance in carrying out violence or any other unlawful activity against any persons, animals or any governments, businesses or other entities
- (b) Describing or displaying a weapon, or parts of weapons, or manuals for assembling any weapon, including but not limited to firearms, ammunition, explosives, grenades, bombs and caustic or other dangerous substances contrary to any laws
- (c) Promoting products or services that involve a significant risk of death or injury to any persons, or damage to business or other entities or property
- 7.1.8 Defamatory or Abusive Language: using our Products as a means to transmit or post defamatory, harassing, abusive, or threatening language

# 7.1.9 Forging of Headers

- (a) Forging or misrepresenting message headers, whether in whole or in part, to mask the originator of the message
- 7.1.10 Illegal or unauthorised access to other computers or networks
- (a) Accessing illegally or without authorisation computers, accounts, or networks belonging to another party, or attempting to penetrate security measures of another individual's system (often known as "hacking")
- (b) Engaging in any activity that might be used as a precursor to an attempted system penetration (i.e. port scan, stealth scan, or other information gathering activity)
- 7.1.11 Distribution of Internet Viruses, Worms, Trojan Horses, or Other Destructive Activities
- (a) Distributing information regarding the creation of and sending Internet viruses, worms, Trojan horses, pinging, flooding, mailbombing, or denial of service attacks
- (b) Engaging in activities that disrupt the use of or interfere with the ability of others to effectively use the network or any connected network, system, service, or equipment

### 7.1.12 Illegal Activities

(a) Engaging in activities that are determined to be illegal, including advertising, transmitting, or otherwise making available ponzi schemes, pyramid schemes, fraudulently charging credit cards, and pirating software

#### 7.1.13 Gambling

- (a) Engaging in or promoting gambling contrary to any laws
- 7.1.14 Promoting Intoxicants
- (a) Displaying or promoting any type(s) of intoxicant, alcoholic beverage, cigarettes or illegal substance contrary to any laws
- 7.1.15 Instructing others in prohibited activities
- (a) Providing instructions with respect to any activities listed in this paragraph 7
- 7.1.16 Engaging in any other activity, whether lawful or unlawful, that we in our sole discretion determines to be harmful to customers, operations, reputation, goodwill, or customer relations.
- 7.2 In the event that you engage in any of the activities above, as determined by us in our sole discretion, we may immediately suspend or terminate access to the Products or terminate our contract with you and recover costs and expenses for any harm caused to us or our suppliers.

#### **8. DATA PROTECTION**

8.1 Vodafone is a data controller for any Customer Personal Data that is processed to manage the Customer relationship for the provision of the Vodafone Business Online service and associated transactions completed in the Vodafone Marketplace. This includes order processing, billing and collections, and customer care and support.

Vodafone is a data processor of Customer or End User Personal Data that is processed for the provision of certain features of the Vodafone Business Online services. Please refer to the Vodafone Business Online Service Specification (at Appendix 2) and Data Processing Schedule included at Appendix 1 below for more information.

Where Vodafone is acting as a data processor, the following shall apply:

- 1. Vodafone provides Vodafone Business Online services in partnership with Hostopia Ireland Ltd. who, where Vodafone are acting as a processor, are a sub-processor.
- 2. Vodafone and its partners may only process User Personal Data in accordance with Customer's instructions as documented and agreed by the parties in this contract. Additional instructions, if any, require prior written agreement between the parties, including agreement on any additional fees payable by Customer to Vodafone and its partners for carrying out such instructions. Customer shall ensure that its instructions comply with Applicable Laws.
- 3. Customer agrees that Vodafone may engage another processor (a "Sub-Processor") to carry out processing activities in the provision of the Product or to fulfil certain obligations of Vodafone under the contract. In the event of the addition of a new Sub-Processor or replacement of an existing Sub-Processor in respect of such processing activities, and where Vodafone is required by applicable privacy law to inform the Customer of those changes Vodafone will either (a) give the Customer at least ten (10) Working Days' prior notice, or (b) list the new or replacement Sub-Processor on an applicable Vodafone website at least ten (10) Working Days before Vodafone authorises and permits the new or replacement Sub-Processor access to User Personal Data in order to give the Customer the opportunity to reasonably object to such changes during such notice period.

- 4. Where Vodafone authorises a Sub-Processor as above, Vodafone will enter into a contract or other legal act with the Sub-Processor and will impose upon the Sub-Processor substantially the same legal obligations as under these Data Protection Terms to the extent required by Applicable Privacy Law and that the Sub-Processor is carrying out the relevant processing activities. Where the Sub-Processor fails to fulfil its data protection obligations under such contract or legal act, Vodafone shall remain liable to the Customer for the performance of that Sub-Processor's obligations.
- 5. Vodafone and its partners may retain the User Personal Data for as long as is required to deliver the Product to the customer. Upon termination of the relevant services, Vodafone shall (except as required otherwise by Applicable Law) destroy or return (at Customer's option) User Personal Data in its possession within 28 days. If Customer opts for Vodafone to retain User Personal Data post termination, the Parties shall enter in a contract for hosting. Hosting services shall be subject to availability. In some circumstances the Customer shall as Data Controller be able to manually delete data themselves or request Vodafone to do so, however Vodafone shall by under no obligation to implement alternate data retention rules at the request of the Customer.
- 6. Vodafone and its sub-processors shall limit access to User Personal Data to those Authorised Persons as necessary to meet Vodafone's obligations in relation to the Product and to such part or parts of the User Personal Data as are strictly necessary for the performance of that Authorised Person's duties. Vodafone shall take reasonable steps to ensure the reliability of any of its Authorised Persons who have access to the User Personal Data and will make sure that all Authorised Persons:
- a) have committed themselves to confidentiality or are under an appropriate statutory obligation of confidentiality;
- b) are trained relating to handling User Personal Data; and
- c) do not process User Personal Data except in line with the instructions from the Customer, unless it is required to do so by Applicable Law.
- 7. Vodafone and its partners shall, taking into account the state of the art, the cost of implementation and the nature, scope, context and purposes of processing as well as risk of varying likelihood and severity of the rights and freedoms of Users, provide appropriate technical and organizational measures for a level of security appropriate to the risks that are presented by processing, in particular from accidental or unlawful loss, destruction, alteration or unauthorised disclosure of or access to User Personal Data transmitted, stored or otherwise processed pursuant to the relevant Product.
- 8. Vodafone and its partners shall, taking into account the nature of the processing and the information available to Vodafone in respect of any of the following:
- a) provide the Customer with such information, assistance and cooperation as Customer may reasonably require to establish compliance with the security measures contained in the Applicable Privacy Law;
- b) without undue delay notify Customer of any unauthorised access to User Personal Data of which Vodafone becomes aware, which results in loss, unauthorised disclosure or alteration to the User Personal Data. Furthermore, Vodafone shall provide reasonable assistance to Customer in relation to any personal data breach notification which the Customer is required to make under Applicable Privacy Law;
- c) where required by Applicable Privacy Law and requested by the Customer (prior to the processing), Vodafone shall provide the

- Customer reasonable assistance to carry out a privacy impact assessment of the Product and any prior consultation of the relevant supervisory authority as required by Applicable Privacy Law.
- 9. With respect to any right of audit, Vodafone and its partners will make available to the controller all information necessary to demonstrate compliance with the obligations set out by Law and allow for and contribute to audits, including inspections, conducted by the controller or another auditor mandated by the controller.
- 10. Vodafone and its partners (sub-processors) may transfer User Personal Data to countries outside the European Economic Area only to the extent that:
- a) User Personal Data is transferred to a territory outside the European Economic Area on terms substantially in accordance with the Transfer Contract Clauses for the transfer of Personal Data to processors established in third countries;
- b) that the transfer of User Personal Data does not put any member of Customer Group in breach of its obligations under Applicable Privacy Law; or
- c) it is required to do so by Union or Member State law to which it is subject; in such a case, Vodafone shall inform the Customer of that legal requirement before processing, unless that law prohibits such information.
- 11. Vodafone: (i) may receive legally binding demands from a law enforcement authority for the disclosure of, or other assistance in respect of, User Personal Data, or be required by applicable law including court order, warrant, or subpoena to disclose User Personal Data to persons other than Customer; (ii) will not be in breach of its obligation to Customer in complying with such obligations to the extent legally bound; and (iii) shall notify Customer as soon as reasonably possible of any such demand unless otherwise prohibited.
- 12. Vodafone shall, where the Customer is required under Applicable Privacy Law to respond to enquiries or communications (including subject access requests) from Users and taking into account the nature of the processing:
- a) without undue delay pass on to Customer any enquiries or communications (including subject access requests) that Vodafone or its sub-processors receives from Users relating to their User Personal Data or its Processing; and
- b) assist the Customer by appropriate technical and organisational measures, insofar as this is possible in the Customer's fulfilment of those obligations under Applicable Privacy Law

Our web consultants engage customers within 24 hours after the initial order and keep in constant contact with them until their website is approved and launched. Once the customers' website or e-Commerce shop is published, customers will typically have a number of "maintenance hours" available to have our designers make ongoing changes to their website. Customers will have their website render responsively to mobile and tablet form factors, and are able to make edits to their website through the Vodafone Online Presence Builder.

#### **Detailed DIFM service description**

### Website & e-Commerce shop design coordination

Each customer is provided a website design consultant to personalise, and thereby enhance, the overall customer experience. The website design consultant deals with the initial and continued conversations throughout the development process. The customer has access to a Project Center, where they can upload the content they wish to be used on their website or e-Commerce shop, such as images, PDFs, or text. A Creative Brief is utilised for content submission, which contains several relevant business-related questions that will ensure an accurate reflection of the customers' website requirements. Via the Project Center, the Creative Brief can be filled out by the customer or by the website coordinator with information received from the customer via phone or email questionnaire.

#### Design & Development

The design and development process encompasses content creation, website design, and quality assurance. For content creation, consideration is given to the information derived from the Creative Brief. The customer may select their pages or have the copywriters select the pages for them. For those who wish to supply their content as a loose reference, our copywriters can enhance and structure it to be aesthetically pleasing on the website. For customers who want nothing more than a final polish on their provided content, copywriters will make minimal adjustments that promote professionalism while maintaining the integrity of the customer's submission. For customers who prefer not to submit anything at all, copywriters can creatively produce content based on business category.

Once a template theme is chosen, it will be personalised with the creative content supplied by the copywriter, incorporating any images, special instructions, or preferences provided by the customer such as appointment scheduling, menu/product list placement and more. The customer can provide as much or as little input as preferred.

Our quality assurance is based on a score card system, created to quantify the quality process, by dividing the review components into weighted sections. This allows for accurate trending and improvement efficiency in website development.

#### Maintenance

The maintenance time allotted per month varies per edition (please see Table 2). Requests filter through a maintenance panel, which places the projects in queue, in the order they are received. The maintenance team works through the orders, notifying the customer once the updates have been completed. A convenient phone option is also available which allows customers to work with the maintenance representative while the changes are being made. Change requests can also be submitted via email or through an update request form available in their Project Center.
