

Samsung Galaxy Z Flip8 & Fold8 Series Launch Offer Terms and Conditions

These terms and conditions apply to the promotional offers from the device launch date of the new Samsung Galaxy Z Flip8 & Fold8 Series (each an “**Offer**” and together the “**Offers**”). The new Samsung Z Flip8 & Fold8 Series includes Samsung Galaxy Z Flip8, Samsung Galaxy Z Fold8 and Samsung Galaxy Z Fold8 Ultra mobile handset devices (“**Eligible Handsets**” and each an “**Eligible Handset**”).

The promoter of the Offers is Vodafone Ireland Limited (“**we**”, “**us**”, or “**Vodafone**”). These terms apply in addition to the General Terms and Conditions under which you enjoy access to Vodafone's Mobile Telecommunications Services (found here: [General Terms and Conditions](#)), the applicable terms for the Bill Pay or Pay as you go plan you have signed up to and any applicable service specific terms. (1) Samsung Galaxy Z Fold8 256GB for €0 when you switch to our Ultra plan

These terms and conditions apply to the promotional offer pursuant to which Eligible Customers may receive a discount of €400 off the price of the Samsung Galaxy Z Fold8 256GB handset device (an "Eligible Handset") when they switch to a 24-month Vodafone Ultra Bill Pay mobile handset plan or, in respect of business customers referenced in Clause 1 below, a 24-month Red Business Unlimited Max mobile handset plan during the Offer Period (the "Offer").
