



## **Vodafone TV PLAY €35 discount for first 6 months offer terms (24 Month) | Digital Exclusive**

The following terms and conditions apply to an offer pursuant to which Eligible Customers can receive a €210 cumulative discount (€15 off broadband and €20 off TV each month for the first 6 months) off the cost of their 24-month minimum term Vodafone Home agreement (the “Offer”). These Offer terms apply in addition to the [General Terms and Conditions](#) under which you enjoy access to Vodafone's Fixed Telecommunications, Broadband, and TV Service and any additional applicable service-specific terms that you have signed up to. These terms form part of your agreement with us. The promoter of the Offer is Vodafone Ireland Limited. By availing of the Offer, you are deemed to have read and agree to be bound by the following terms and conditions:

- 1) The Offer is available to “Eligible Customers” only. Eligible Customers are:
  - a) new Vodafone Home customers who create a new fixed broadband connection with Vodafone on a 24-month minimum contract term during the Offer Period; or
  - b) new Vodafone Home customers who create a Broadband and Vodafone TV PLAY Bundle with Vodafone on a 24-month minimum contract term during the Offer Period.
- 2) new Vodafone Home customers who are connecting via the NBI fibre broadband network (“NBI Customers”) are only eligible to receive a maximum €150 cumulative discount (€20 discount off TV and €5 digital-exclusive broadband discount each month for 6 months) on a 24-month minimum contract term, when ordering exclusively from the website: [vodafone.ie](http://vodafone.ie) during the Offer Period. For the avoidance of doubt the €5 monthly broadband discount is not available to NBI Customers via [Bonkers.ie](http://Bonkers.ie).

- 6) Pursuant to this Offer, Eligible Customers will receive a €35 discount on their Vodafone Home bill each month for the first 6 months of their 24-month minimum contract term (maximum €210 total discount) (the “Discount”). Vodafone Fibre Broadband and TV packages start from €65 per month depending on package chosen.



- 7) Eligible Customers cannot avail of this Offer if they are availing of the Converged “mobile and broadband” Offer discount or the Red Family Converged discount.
