

Apple iPhone 18 Pro and iPhone 18 Pro Max Launch Terms & Conditions

These terms and conditions apply to the promotional offer pursuant to which Eligible Customers may receive €100 off when purchasing the iPhone 18 Pro 256GB (the “Eligible Handset”) and switching to any of our 24-month bill pay handset plans (the “Designated Plans”) during the Offer Period (the “Offer”). The promoter of the Offer is Vodafone Ireland Limited (“Vodafone”).

These terms apply in addition to the General Terms and Conditions under which you enjoy access to Vodafone's Mobile Telecommunications Services (found here: [Terms | Vodafone Ireland](#)) and any applicable service specific terms. 2. Eligible Customers who avail of the Offer and meet the conditions set out in these terms may receive €100 off the price of the Eligible Handset.
3. The Offer is valid between 18th September 2026 and 30th November 2026 (the “Offer Period”).
4. Eligibility is determined by Vodafone in accordance with these terms and conditions. Vodafone's decision in respect thereof shall be final.
5. The Offer is available on Vodafone.ie, Vodafone retail and Vodafone franchisee stores only.
