

## **RED Unlimited and Unlimited Max Switch & Save offer (Christmas)**

These terms and conditions apply to the Vodafone Bill Pay Christmas 2024 promotional offer pursuant to which Eligible Customers can receive €200 off a handset when they sign up to a 24-month RED Unlimited or RED Unlimited Max bill pay plan during the Offer Period (the “Offer”). The promoter of the Offer is Vodafone Ireland Limited. These Offer terms will apply in addition to the [General Terms and Conditions](#) under which you enjoy access to Vodafone's Mobile Telecommunications Services and any additional applicable service specific terms that you have signed up to. These terms form part of your agreement with Vodafone. By availing of the Offer, you are deemed to have read and agree to be bound by the following terms and conditions:

1. This Offer is available to “Eligible Customers” only. Eligible Customers are “new to Vodafone bill pay” customers who sign up to a Vodafone RED Unlimited or RED Unlimited Max bill pay plan on a 24-month contract during the Offer Period. This offer excludes 12-month Sim Only plans, 30-day plans, non-unlimited plans, and mobile broadband plans. “New to Vodafone bill pay” customers mean customers who (a) switch their mobile number to Vodafone from another mobile network provider, (b) are first time connections (c) are prepay to post pay connections. For the avoidance of doubt, it includes New to Vodafone bill pay customers who sign up to a 24-month Vodafone Red Unlimited bill pay plan as part of a Red Family account also. Existing Vodafone bill pay customers and deferred ports cannot avail of the

Offer. Eligibility is determined by Vodafone in accordance with these terms and conditions and Vodafone's decision in respect thereof shall be final.

2. The Offer Period is 1 November 2024 to 6 January 2025 only (the “Offer Period”).
3. Eligible Customers who sign up to a RED Unlimited or a RED Unlimited Max 24-month plan during the Offer Period will receive €200 off all handsets which are not ‘Selected Handsets’.
4. Selected Handsets’ will have a specific discount on RED Unlimited. The ‘Selected Handsets’ and associated discounts are as follows:
  - i. iPhone 15 (128GB) - €280 discount
  - ii. Samsung S24 (128GB) - €150 discount

11. In the event of abuse or fraud affecting the proper operation of the Offer, Vodafone reserves the right, in its sole discretion, to refuse participation in the Offer and/or to fully revoke the Offer.
12. By deciding to avail of the Offer, you agree that we will provide you with service before the expiry of your 14-day cancellation period and you acknowledge that you may be liable for any service charges incurred during the cancellation period even if you cancel the contract.
13. Except as expressly provided in these terms and conditions, all conditions, terms, warranties and representations whether express or implied by law in relation to the provision of the Offer are excluded to the fullest extent permitted by law.
