

## **Vodafone RED Unlimited iPhone17 Porting & Trade In Offer Terms & Conditions**

These terms and conditions apply to the promotional offer pursuant to which Eligible Customers may receive an iPhone17 128GB for €0 upfront when they (i) switch to our 24-month RED Unlimited plan (the “Designated Plan”) and (ii) trade in a handset that is Eligible and Relevant during the Offer Period (the “Offer”). The promoter of the Offer is Vodafone Ireland Limited.

These terms apply in addition to the General Terms and Conditions under which you enjoy access to Vodafone's Mobile Telecommunications Services (found here: <https://www.vodafone.ie/terms>) and any applicable service specific terms. These terms form part of your agreement with us. By availing of the Offer, you are deemed to have read and agree to be bound by the following terms and conditions:

1. This Offer is available to “Eligible Customers” only. Eligible Customers are customers who trade in a handset that is Eligible and Relevant and; (i) port their mobile number to the Designated Plan, from another network provider or (ii) sign up to the Designated Plan as a first-time connection, or (iii) customers who move from a Vodafone Pay As You Go plan to the Designated Plan. This Offer excludes existing Vodafone customers moving from any other Vodafone Bill Pay plan.
2. The Offer applies to Eligible and Relevant handsets only. For a trade in handset to be:
  - a. Eligible: it must be in good working condition, and it must adhere to the conditions set out in the General Trade in Terms and Conditions viewable here: <https://n.vodafone.ie/terms/pay-as-you-go.html>; and
  - b. Relevant: must have a trade in value of at least €159.99.
3. To avail of the Offer, during the Offer Period, Eligible Customers must: (i) switch or sign up to the Designated Plan; (ii) trade in a handset that is Eligible and Relevant; AND (iii) select an iPhone17 128GB.
4. Eligible Customers who avail of the Offer and meet the Offer conditions may receive an iPhone17 128GB for €0 upfront.
5. The Offer is valid between 8AM on 19<sup>th</sup> September 2025 and 8AM on 14<sup>th</sup> November 2025 (the “Offer Period”).
