

Vodafone RED Lite iPhone 15 Porting & Trade In offer

These terms and conditions apply to the promotional offer pursuant to which Eligible Customers may receive an iPhone 15 on us when they (i) switch to our 24-month RED Lite plan (the “Designated Plan”) and (ii) trade in a handset that is Eligible and Relevant during the Offer Period (the “Offer”). The promoter of the Offer is Vodafone Ireland Limited.

These terms apply in addition to the General Terms and Conditions under which you enjoy access to Vodafone's Mobile Telecommunications Services (found here: <https://n.vodafone.ie/terms/bill-pay.html>) and any applicable service specific terms. These terms form part of your agreement with us. By availing of the Offer, you are deemed to have read and agree to be bound by the following terms and conditions:

1. This Offer is available to “Eligible Customers” only. Eligible Customers are customers who trade in a handset that is Eligible and Relevant and; (i) port their mobile number to the Designated Plan, from another network provider, or (ii) sign up to the Designated Plan as a first-time connection, or (iii) customers who move from a Vodafone Pay As You Go plan to the Designated Plan.

2. The Offer applies to Eligible and Relevant handsets only. For a trade in handset to be:

a. Eligible: it must be in good working condition, and it must adhere to the conditions set out in the General Trade in Terms and Conditions viewable here: <https://n.vodafone.ie/terms/pay-as-you-go.html>; and

b. Relevant: must be an iPhone 10 or newer iPhone model and have a trade in value of €200 minimum.

3. To avail of the Offer, Eligible Customers must contemporaneously (i) switch or sign up to the Designated Plan, (ii) trade in a handset that is Eligible and Relevant, and (iii) select an iPhone 15.

4. Eligible Customers who avail of the Offer will receive an iPhone 15 on us. The Offer is valid between 1st April 2024 and 30th June 2024 (the “Offer Period”).

5. Eligibility is determined by Vodafone in accordance with these terms and conditions. Vodafone's decision in respect thereof shall be final.

6. The Offer is available in Vodafone retail and franchisee stores only.

7. Handset pricing is subject to change and the Offer is strictly subject to availability.

8. This Offer excludes existing Vodafone customers moving from any other Vodafone Bill Pay plan.

9. Vodafone reserves the right to extend or withdraw the Offer at any time and/or to vary or amend any element of the Offer at any time without further notice.

10. Vodafone further reserves the right to vary or amend these terms and conditions for valid commercial, technical or operational reasons.

11. In the event of abuse or fraud affecting the proper operation of the Offer, Vodafone reserves the right, in its sole discretion, to refuse participation in the Offer and/or to fully revoke the Offer.
