- 01** **STEP 1:** The Vodafone account must be in your name as specified in your staff identification.
- 02** **STEP 2:** You must read and agree to the conditions of this form by ticking the box below.
- 03** **STEP 3:** Attach and email this form from your company email address within 3 months of connection to: [vodafoneaffinityprogram.ie@vodafone.com](mailto:vodafoneaffinityprogram.ie@vodafone.com)
- 04** **STEP 4:** Once set up, our team will email you and your discount will be applied to your next eligible bill.

### TERMS AND CONDITIONS FOR RECEIVING VODAFONE EMPLOYEE DISCOUNT

1. Your employment with your company may permit you to obtain mobile services from Vodafone Ireland Limited at a discount on eligible plans – RED Lite, RED Unlimited, RED Unlimited Max, RED Unlimited SIM Only, RED Unlimited SIM Only Max and Gigabit 1000 Fibre Broadband. Please check with your employer whether you are eligible.
2. The discount only applies to one mobile and one broadband connection for your use only.
3. The discount applies to new connections only for the duration of the initial contract and must be requested within 3 months of the connection date. Discount is not available for existing Vodafone customers. If the customer re-commits or starts a new contract the discount will be removed.
4. The discount is based on your employer's agreement with Vodafone. From time to time, your discount rate may be adjusted in accordance with your employer's agreement with Vodafone.
5. Vodafone reserves the right to withdraw the discount if you leave the company or if the company ceases to be a Vodafone customer.
6. These Employee Advantage Scheme terms and conditions apply in addition to, and form part of, the General Terms and Conditions of your existing Vodafone customer contract. The General Terms and Conditions of your existing customer contract with Vodafone are available for your information at [Vodafone.ie/terms](http://Vodafone.ie/terms).
7. The discount you receive under the Employee Advantage Scheme does not affect any Early Termination Fee that you are liable to pay should you terminate your contract with Vodafone early.
8. Vodafone will keep a record of your company email address and, from time to time, will share this with your employer to verify your continued eligibility for the affinity discount.
9. If your employment changes or is terminated, you are required to notify Vodafone, as you will no longer be eligible for the discount. If a review of your employment status by Vodafone reveals that you are no longer an employee of the company, Vodafone reserves the right to remove any discount and move you to the most similar commercially available tariff or to a non-discounted tariff for the remainder of your contract term.
10. New connections to Vodafone bill pay may be subject to a deposit or advance payment. Direct Debit is mandatory.
