

One Month Free Ultra SIM Only - April 2026

These terms and conditions apply to the Vodafone promotional offer being run by Vodafone Ireland Limited pursuant to which Eligible Customers who sign up online, via telesales or through a Vodafone Retail store to our 12-month Ultra SIM Only plan (the “Designated Plan”) between 1st April 2026 and 30th April 2026 (inclusive) will receive one month of the Designated Plan for free (the “Offer”).

These terms apply in addition to the General Terms and Conditions under which you enjoy access to Vodafone's Mobile Telecommunications Services (found here: [General Terms and Conditions](#)) and any applicable service-specific terms. These terms form part of your agreement with us. By availing of the Offer, you are agreeing to the following terms:

1. This Offer is available to “Eligible Customers” only. Eligible Customers are new Bill Pay customers (Ports and FTCs) and existing customers moving from Prepay to Bill Pay who sign up to the Designated Plan between 1st April 2026 and 30th April 2026 (inclusive) (the “Offer Period”).

Eligible Customers who remain Vodafone customers following their statutory 14-day cooling-off period will have one €25 credit placed on their account (which equates to the monthly price of the Designated Plan where the promotion of €10 off per month for the first 6 months is applied). If the credit is not applied to the first bill, it will be reflected on the second bill.
3. The Offer is limited to one €25 credit per Eligible Customer. The credit is non-transferable, non-exchangeable, and non-redeemable for cash or goods.
4. This Offer is available online on Vodafone.ie, Telesales and via a Vodafone Retail store.
5. Vodafone reserves the right to extend or withdraw the Offer or vary or amend the Offer Period or any element of the Offer at any time without further notice.
6. Vodafone further reserves the right to vary or amend these terms and conditions for valid commercial, technical, or operational reasons.
7. Eligibility is determined by Vodafone in accordance with these terms and conditions. Vodafone's decision in respect thereof shall be final.

9. The Offer cannot be used in conjunction with any other offer or promotion (with the exception of the introductory Ultra SIM Only offer of €10 off per month for the first 6 months, as referenced at Clause 2 above, if applicable).
