

Vodafone 5G Unlimited Broadband

The following terms and conditions (the “Terms”) apply to use of Vodafone Ireland Limited’s (“Vodafone”) 5G Unlimited Broadband (“5G Unlimited Broadband”) and are in addition to and form part of the General Terms and Conditions of the Vodafone Mobile Telecommunications Service (the “General Terms”) and any additional terms you have signed up to, all of which are available [here](#). We recommend you download and save a copy of the terms for your future reference. If there is any conflict between terms, then the order of precedence shall be as follows: the terms, followed by the General Terms.

By signing up to 5G Unlimited Broadband, you are deemed to have read and agreed to be bound by the following terms:

1. 5G Unlimited Broadband enables Vodafone customers who have signed up to this price plan to use data services via their Vodafone SIM Card using an 5G Unlimited Broadband modem.
2. See all charges for 5G Unlimited Broadband [here](#).
3. The 5G Unlimited Broadband plans provide unlimited data, subject to network coverage and availability and the data roaming limitations stated at Clause 8 below.
4. 5G Unlimited Broadband is subject to a 3-month, 12-month or 24-month minimum term contract as selected by the customer. After the relevant minimum term has expired (subject to Vodafone having sent the required advance notification to you and the plan not having been cancelled or changed), we will continue to provide you with 5G Unlimited Broadband on a rolling monthly basis until either of us decides to end our Agreement in the ways set out in our General Terms. During this period post-expiration of the minimum term, you can cancel the 5G Unlimited Broadband at any time with 30 days’ notice by contacting us via Live Chat, Care or a retail store; see <https://n.vodafone.ie/support.html>. Please note if you cancel 5G Unlimited Broadband during the minimum term, you will have to pay an Early Termination Fee
5. 5G Unlimited Broadband is made available at the discretion of Vodafone and Vodafone reserves the right to withdraw 5G Unlimited Broadband generally or from any particular Customer at any time.
6. Vodafone reserves the right to vary, amend, alter or withdraw this price plan and/or its terms for any valid commercial, technical, operational, legal and/or regulatory reasons at any time without further notice.

7. Eligibility is determined by Vodafone in accordance with the Terms and the General Terms. Vodafone's decision in respect thereof shall be final.

8. 5G Unlimited Broadband is subject to mobile equipment capability, network coverage and availability. See detailed speed information [here](#).

9. Data Roaming is excluded from 5G Unlimited Broadband. For the avoidance of doubt, this price plan will only work within the Republic of Ireland.

10. Use of, and access to, 5G Unlimited Broadband is strictly subject to you using our Services for your private, personal, and legitimate consumer purposes only. You must not use 5G Unlimited Broadband for commercial or fraudulent purposes. If Vodafone is of the opinion that your usage is contrary to these principles (for example, if your usage is excessive to the extent that it is negatively impacting the Vodafone Network, or if your usage constitutes commercial or fraudulent use or is in breach of the law), Vodafone reserves the right, exercisable at its absolute discretion, to suspend, modify or restrict use of the service or to disconnect you from the Vodafone Network. Vodafone will make reasonable efforts to contact you before suspending or terminating the Services, but Vodafone are not liable for any loss you may suffer through any suspension, modification or restriction covered by this condition.

11. If for any reason you wish to cancel your plan and return your 5G Unlimited Broadband modem to a Vodafone Retail store, you can do so within fourteen days of purchasing the modem and receive a full refund on all charges incurred during this time (including a full refund of your first month's 5G Unlimited Broadband tariff). The same return policy applies for new and 'As New' modems. No termination charges will apply for cancellations actioned within this fourteen-day period. In order to avail of this returns policy, the modem must not be faulty due to damage caused to it whilst in your possession and must be returned complete with the 5G Unlimited Broadband SIM card, proof of purchase, packaging, cables and user guide. This does not affect your cancellation rights and other rights you may have under the the Consumer Rights Act 2022 (S.I. No. 37 of 2022).

12. Capitalised terms used and not defined in these Terms shall be defined in accordance with the General Terms.

13. Except as expressly provided in these terms and conditions, all conditions, terms, warranties, and representations whether express or implied by law in relation to the provision of 5G Unlimited Broadband are excluded to the fullest extent permitted by law.
