#### **Why am I receiving this notice?**

Under EU regulation we're required to provide you with an end of contract notification and information and advice on price plans that best suit your requirements when you're coming to the end of the minimum term on your contract. We are also required to notify you once in every 12 month period if you choose to remain on your price plan after the minimum term is over.

If you want to give us notice, please contact Customer Care via any of the ways set out in our Code of Practice, a copy of which is available on Vodafone.ie. If you cancel before your minimum term ends, you may have to pay an early termination fee.
