

Half Price for 6 months Ultra SIM Only – 31st July

These terms and conditions apply to the promotional offer being run by Vodafone Ireland Limited (“Vodafone”) pursuant to which Eligible Customers who sign up to our 12-month Ultra SIM Only plan (the “Designated Plan”) from 31st July 2026 will receive €17.50 off per month for the first 6 months on the Designated Plan (the “Offer”).

These terms apply in addition to the General Terms and Conditions under which you enjoy access to Vodafone's Mobile Telecommunications Services (found here: [General Terms and Conditions](#)), the Ultra SIM Only plan terms and conditions and any applicable service-specific terms. These terms form part of your agreement with us. By availing of the Offer, you are deemed to have read and agreed to the following terms:

1. This Offer is available to “Eligible Customers” only. Eligible Customers are new Bill Pay customers (Ports and FTCs/first time customers) and existing customers moving from Prepay to Bill Pay who sign up to the Designated Plan from 31st July until the Offer is withdrawn by Vodafone (the “Offer Period”).
2. Eligible Customers who remain Vodafone customers following their statutory 14-day cooling-off period will receive €17.50 off per month for the first 6 months, which, at the date of this Offer, equates to a monthly charge of €17.50 for the first 6 months of the Designated Plan. After this 6-month promotional period, the monthly charge will return to the agreed contract price (being, at the date of the Offer, €35 per month) for the remainder of the contract period.
3. Eligibility is determined by Vodafone in accordance with these terms and conditions. Vodafone's decision in respect thereof shall be final.
4. This Offer is available online on Vodafone.ie, Telesales and via a Vodafone Retail store.
5. The discount under the Offer shall be automatically applied to the Eligible Customer's bills and the discount is non-transferable, non-exchangeable, and non-redeemable for cash, credit or goods.
6. Vodafone reserves the right to extend or withdraw the Offer or vary or amend the Offer Period or any element of the Offer at any time without further notice.
7. Vodafone further reserves the right to vary or amend these terms and conditions for valid commercial, technical, or operational reasons.

9. The Offer is subject to signing up to a 12-month minimum contract term Designated Plan. Early termination charges will apply if you cancel your service before the end of your minimum term. Out of contract standard pricing applies.
