## Switcher.ie Terms Sept 1st 2024

The following terms and conditions apply to an offer pursuant to which Eligible Customers purchasing Vodafone services via Switcher.ie can receive (i) a €60 discount (€10 each month for 6 months) off the cost of their Vodafone Home contract (the "Offer") and (ii) subject to adding TV to their Vodafone Home contract, an additional €30 discount (€5 off each month for 6 months).
