

Pay As You Go Porting Offer –September 8th to 22nd 2026, Xiaomi Redmi 17 5G Flash Sale

These terms and conditions apply to the Vodafone Ireland Limited (“Vodafone”) promotional offer pursuant to which Eligible Customers may receive a discount off the price of the Xiaomi Redmi 17 5G mobile handset (the “Eligible Device”) (the “Offer”). These terms will apply in addition to the General Terms and Conditions under which you enjoy access to Vodafone's Mobile Telecommunications Services and any applicable service-specific terms. These terms form part of your agreement with us. By availing of the Offer, you are deemed to have read and agreed to be bound by the following terms:

1. This Offer is available to Eligible Customers only. “Eligible Customers” are customers who port their mobile number to Vodafone Pay as You Go from another network provider during the Offer Period. This Offer excludes existing Vodafone customers moving from Vodafone Bill Pay to Vodafone Pay as you go, existing Vodafone Pay as you go customers, new Vodafone Pay as you go customers who have not ported to Vodafone from another provider (e.g. customers setting up a new number with Vodafone and not porting) and deferred ports. Eligibility is determined by Vodafone in accordance with these terms and conditions. Vodafone’s determination in respect of eligibility shall be final.
2. Access to 5G network is subject to having a 5G enabled plan and 5G coverage. Coverage is subject to location and availability and may be affected by a number of factors.
3. This Offer is available from 09.00am September 8th to September 22nd 2026, inclusive (the “Offer Period”).
4. This Offer is available online at vodafone.ie and Vodafone retail and franchise stores.
5. To activate the Offer, Eligible Customers who switch to Pay as You Go must complete an Activation Top Up of at least €20 in a single transaction.
6. Under the Offer (once activated in line with Clause 5 above), Eligible Customers who purchase the Eligible Device during the Offer Period will receive a €200 discount on the price of the Eligible Device. The €200 will be deducted from the phone’s price at the time of purchase.
7. The Offer is strictly subject to availability and device pricing is subject to change.
8. The Offer is in addition to any Vodafone promotional retail pricing on the Eligible Device and to any applicable Vodafone promotional offers for Pay as You Go customers (including the “Second Month Free” offer). Subject to this, this Offer cannot be used in conjunction with any other promotion or offer.

9. Eligible Customers may only receive one discount each under this Offer.
10. The Offer discount is non-transferable, non-exchangeable and non-redeemable for cash or goods (other than the Eligible Device in line with the terms of the Offer).
