

## Samsung Galaxy S26 Series Pre-order Terms and Condition

These Pre-Order Terms and Conditions (the “Pre Order Terms”) govern the placing of pre-orders with Vodafone Ireland Limited (“we”, “us”, or “Vodafone”) for the Samsung Galaxy 26 Series mobile handset devices (“Eligible Handsets” and each an “Eligible Handset”). These terms apply in addition to the General Terms and Conditions under which you enjoy access to Vodafone's Mobile Telecommunications Services (found here: <https://www.vodafone.ie/terms>) and any applicable service specific terms. These terms form part of your agreement with us.

Please read these Pre Order Terms carefully before submitting your pre-order. By submitting your pre-order, you agree to be legally bound by these terms:

1. The pre-order period for the Eligible Handsets is from 25<sup>th</sup> February 18:00 (GMT) to 10<sup>th</sup> March 23:59 (GMT) (the “Pre Order Period”). The Eligible Handsets will be available for general sale on 11<sup>th</sup> March 2026.
2. The pre-order is available to Eligible Customers only. Eligible Customers are residents of the Republic of Ireland aged 18 years of age or older, who pass our credit check and accept Vodafone Bill Pay and Pay As You Go terms and conditions. Pre-orders are available to new Bill Pay customers who during the Offer Period (i) port their mobile number to Vodafone’s network on the 24-month Bill Pay RED Unlimited handset plan (the “Plan”) from another network provider excluding Lyca Mobile and Tesco Mobile, or (ii) sign up to the Plan as a first time connection, or (iii) move from a Vodafone Pay As You Go plan to the Plan.
3. We reserve the right not to accept your pre-order request if you do not meet any relevant eligibility criteria, status requirements or credit check.
4. Eligible customers may submit a pre-order request for Eligible Handsets during the Pre Order Period on Vodafone.ie, Vodafone Retail stores and Franchise partners.
5. Please note that Eligible Handset stock for the Pre Order Period is available on a first come, first served basis and all pre-order requests are strictly subject to availability of stock. Pre-orders are available while stocks last, and this facility may be withdrawn to avoid oversubscription or as we deem necessary.
6. Where possible orders will be shipped to as soon as is practicable, subject to availability, so that you may receive it on the release date. We will endeavour to follow the below timelines for all pre-orders made during the Pre Order Period:
  - a. For Retail pre-orders, customers must pay a €50 deposit as part of the pre-order sale, and they must return to the store on or after the 11th of March 2026 to collect their device when ready and pay the outstanding balance or their pre-order will be void. Where the device is free, the €50 can be used against the purchase of accessories in store.
  - b. For online pre orders, customers must pay the full upfront cost at the point of pre order.

c. Online pre-orders placed from 25<sup>th</sup> February 18:00 (GTM) will be shipped from 11<sup>th</sup> March and could take up to 14 days to arrive with the customer.

7. Delivery of pre ordered Eligible Handsets is subject to availability and supply from Samsung.
8. All remaining orders will be subject to standard online delivery timelines, and terms and conditions. For all delivery related queries please contact us at our Help and Support hub at <https://n.vodafone.ie/support.html>.
9. When placing a pre-order, you will be required to provide certain information, such as your address and billing information. You represent and warrant that all such information is accurate, and we will have no responsibility or liability for inaccurate information.
10. If for any reason, we cannot fulfil your pre-order, we will cancel your order and refund any payments made. We will endeavour to contact you about this prior to cancelling your order.
11. Vodafone reserves the right to vary, withdraw and/or cancel this pre-order offer at any time for valid commercial, technical, operational and/or regulatory reasons.
12. We reserve the right at our absolute discretion to vary, delete or add to any of these Pre Order Terms.
