

Samsung Disney+ 12 months Subscription Promotion

The following terms and conditions apply to the Samsung Disney+ 12 months Subscription Promotion pursuant to which customers who purchase and activate a new Samsung Galaxy S23, Galaxy S23+, Galaxy S23 Ultra, Galaxy Z Fold5 5G, or Galaxy Z Flip5 5G ("each a Promotion Product") within the promotion period will be entitled to a Disney+ 12-month subscription by redemption (the "Offer"). These terms will apply in addition to the General Terms and Conditions under which you enjoy access to Vodafone's Mobile Telecommunications Services and any applicable service specific terms. These terms form part of your agreement with us. By availing of this Offer, you agree to the following terms:

1. The Offer is available to Eligible Customers only. Eligible Customers are individuals who purchase a new Promotion Product from Vodafone as part of any type of (i) new, porting or upgrading Vodafone Bill Pay connection or (ii) new, porting or upgrading Vodafone PAYG connection and (iii) satisfy the requirement at section 2 below. Eligibility is determined by Vodafone in accordance with these terms and conditions. Vodafone's determination in respect thereof shall be final.
2. The offer is available to new and returning Disney+ users (i.e., individuals that do not have an active Disney+ account) only. A valid debit or credit card is required, and by redeeming the code Eligible Customers will be entering into a monthly subscription. The subscription will begin when the Eligible Customer receives the confirmation email from Disney+ notifying of successful completion of the registration process.
3. The Offer is available for Promotion Products purchased between 00:01 GMT on 01 November 2023 until 23:59 GMT on 31 March 2024. Promotion Product pricing is subject to change.
4. The Offer is available for Promotion Products purchased via any Vodafone sales channel (online, in-store and by phone).
5. This Offer is strictly subject to availability.
6. The Promotion Product must be purchased during the Promotion Period and is redeemable by the Eligible Customer: (i) through registration of the Promotion Product and other details in the Eligible Customer's Samsung account on [samsung.com/ie/boost/disneyplus](https://www.samsung.com/ie/boost/disneyplus) (ii) following successful registration and validation of the Promotion Product, receiving a Disney+ activation code ("Disney+ Code"); and (iii) the Eligible Customer accepting the Disney+ Subscriber Agreement and Privacy Policy and redeeming the Disney+ Code at <https://www.disneyplus.com>. 7. The Disney+ 12-month subscription will be provided to Eligible Customers via redemption. Eligible Customers can claim this through their Samsung account and subject to providing details and all other required information into their Samsung account. The offer can be accessed on www.samsung.com/ie/boost. Once the information is provided on the

user's Samsung account, a Disney+ code shall be available for redemption until 31st January 2024 (by 23:59 BST). The code is a one-off, non-transferable and cannot be exchanged or used for resale.

8. Eligible Customers must claim their Disney+ 12-month subscription between 00:01 GMT on 01 November 2023 and 23:59 GMT on 31 March 2024. The final date to redeem the Disney+ Code is by 23:59 BST on 1 May 2024. Claims and code redemptions received after this date will be invalid.
9. Eligible Customers cannot claim the Disney+ 12-month subscription if they have returned the Promotion Product to Vodafone for refund or exchange.
10. The Disney+ Code is redeemable until 23:59 BST on 1 May 2024. A Disney+ Code is not redeemable or refundable for cash and cannot be resold or combined with any other special or free offers or exchanged for Disney+ gift subscriptions. Use of a Disney+ Code is subject to applicable law. A maximum of one Disney+ Code may be applied to your Disney+ account.
11. The Disney+ 12-month subscription is not exchangeable or redeemable for cash or for any other item. In the event of unforeseen circumstances, an alternative reward of equal or greater value may be substituted in place of the Gift.

subscriptions at any time. To cancel, log into your Disney+ account and follow the cancellation instructions. No refunds or credits for partial months.
