

## Mobile Bill Pay Plans

### Notification regarding your price plan

#### **Why am I receiving this notice?**

Under EU regulation we're required to provide you with an end of contract notification and information and advice on price plans that best suit your requirements when you're coming to the end of the minimum term on your contract. We are also required to notify you once in every 12 month period if you choose to remain on your price plan after the minimum term is over.

#### **What advice is included?**

We have set out below a number of possible service options and price points which you can choose to suit your individual likely needs. The mobile voice price plan details are based on whether you want to get a new phone or whether you prefer to keep your existing phone.

#### **Can I stay on my existing price plan?**

You can of course stay on your existing price plan if that is your preference and no action is required. This message is simply designed to make you aware of the options that are currently available which may have changed since you connected to your current plan.

#### **How can I change my price plan?**

You can change your plan at the end of your minimum term which is included in our text message or email to you. If you want to change your price plan, please go to [Vodafone.ie](http://Vodafone.ie) on or after this end date and you can make the change there. You can also change your plan in a Vodafone retail store or by contacting us directly.

You should check this information on or after the end date of your minimum term as notified in the message to get the most up to date handset pricing.

#### **What if I want to cancel my service?**

You may cancel your service at any time by giving us at least 30 days' notice or, if you have a mobile plan with Vodafone, by Porting to another mobile Network Operator. If you want to give notice, please contact Customer Care via any of the ways set out in our Code of Practice, a copy of which is available on [Vodafone.ie](http://Vodafone.ie). If you cancel before your minimum term ends, you may have to pay an early termination fee.
