

Vodafone Fixed €5 discount for 6 months offer general TV terms | September 2025

The following terms and conditions apply to an offer pursuant to which Eligible Customers can receive a €30 discount (€5 each month for the first 6 months) off the cost of their Vodafone Home agreement (the “Offer”). These Offers terms apply in addition to the General Terms and Conditions under which you enjoy access to Vodafone's Fixed Telecommunications and Broadband Service and any additional applicable service-specific terms that you have signed up to. These terms form part of your agreement with us. The promoter of the Offer is Vodafone Ireland Limited. By availing of the Offer, you are deemed to have read and agree to be bound by the following terms and conditions:

- 1) The Offer is available to “Eligible Customers” only. Eligible Customers are:
 - a) new Vodafone Home customers who create a new fixed broadband connection with Vodafone on a 12-month minimum term contract during the Offer Period;
 - b) new Vodafone Home customers who create a Broadband and Vodafone TV PLAY Bundle with Vodafone on a 12-month minimum term contract during the Offer Period;
 - c) existing Vodafone fixed home broadband customers upgrading from low speed plan (less than 100mbps) to Fibre network (500mbps or higher) with Vodafone on a 12month minimum term contract during the Offer Period; or
 - d) existing Vodafone fixed home broadband customers who add Vodafone TV PLAY to their account on a 12-month minimum term contract during the Offer Period. Please note, new Vodafone Home customers who are connecting via the NBI fibre broadband network are only eligible to receive the discount when signing up on Vodafone.ie.
- 2) Eligibility is determined by Vodafone in accordance with these terms and conditions and Vodafone's decision in respect thereof shall be final.
- 3) The Offer is valid between 2nd of December 2024 –31st January 2026 inclusive (the “Offer Period”).
- 4) The Offer is available via Vodafone direct sales channels.
- 5) Eligible Customers will receive a €5 discount on their Vodafone Home bill each month for the first 6 months of their 12-month contract (maximum €30 total discount). Vodafone Fibre Broadband packages start from €40 per month depending on package chosen.
- 6) Eligible Customers cannot avail of this Offer if they are availing of the Converged “mobile and broadband” Offer discount or the Red Family discount.
- 7) Offer subject to signing up to a 12-month minimum term Vodafone Home services contract. Early termination charges will apply if you cancel your service before the end of your minimum term.
