

Smartwatch Discount Offer – Black Friday & Christmas 2025

Terms & Conditions

These terms and conditions apply to the Vodafone Bill Pay Black Friday & Christmas 2025 promotional offer pursuant to which Eligible Customers can receive a €60 discount off smartwatches when they purchase a smartwatch during the Offer Period (the “Offer”). The promoter of the Offer is Vodafone Ireland Limited. 6. Smartwatch Bundle Eligible Customers who purchase a smartwatch through the Smartwatch Bundle will receive this discount as a €2.50 reduction in their monthly price for the duration of their contract.
