

The following terms and conditions apply to the Vodafone Mobile Rugby Competition (the “Competition”). These terms and conditions apply in addition to the Vodafone General Competition. 2. Competition winners entering between 12:00 the 3rd of February and 08:59 the 9th of February will win a pair (two) tickets for the Ireland v Italy Six Nations Rugby match taking place in the Aviva Stadium on the 14th of February 2026 (the “Prize”).
