

Vodafone Fixed €8 ex VAT discount for 24 months offer terms and conditions based on 24-month minimum contract term and 1GB/2GB speed tariff | May 2026:

The following terms and conditions apply to an offer pursuant to which Eligible Customers can receive the Discount on their Vodafone Business agreement (the “Offer”). These Offer terms apply in addition to the General Terms and Conditions under which you enjoy access to Vodafone's Fixed Telecommunications and Broadband Service and any additional applicable service-specific terms that you have signed up to. These terms form part of your agreement with us. The promoter of the Offer is Vodafone Ireland Limited (“Vodafone”). By availing of the Offer, you are deemed to have read and agreed to be bound by the following terms and conditions:

1. “Vodafone Business” means Vodafone Broadband.
2. The Offer is available during the Offer Period to “Eligible Customers” only. Eligible Customers are new Vodafone Business customers who create a new fixed broadband connection with Vodafone on a 24-month minimum contract on a 1GB or 2GB speed tariff.
3. Eligibility is determined by Vodafone in accordance with these terms and conditions and Vodafone's decision in respect thereof shall be final.
4. The Offer is valid between 27 May 2026 and 31 December 2026 inclusive (the “Offer Period”).
5. The Offer is available via Vodafone direct sales channels and affiliate channels.
6. Eligible Customers who avail of the Offer will receive a €8 ex VAT discount on their Vodafone Business bill each month for the 24 months of their 24-month minimum contract term (maximum €192 ex VAT total discount) (the “Discount”).
7. The Offer is subject to the Eligible Customer signing up to a 24-month minimum contract term Vodafone Business services contract. Early termination charges will apply if you cancel your service before the end of your minimum term. Out of contract standard pricing applies.
